2020 Tehachapi Farmers Market



Farmers Market is scheduled for every Thursday from May 7th through August 13th, from 4:00 p.m. to 7:30 p.m. (rain or shine). If you are interested in participating in the Farmers Market, please fill out the attached application, and return it to MST at the address below with your fee. The fee and your completed application must be received in the MST office **no later than 30 days before** the start of the event.

If you do not have a City of Tehachapi Business License an additional \$5.00 is required. If you have a City of Tehachapi Business License, please attach a copy to the application. The fee below covers the entire season's event and is **non-refundable. This application must accompany payment, insurance certificate with MST as additional insured (see specific verbiage that follows) with dates to cover the market season. Failure to do so will delay application approval which will be first come, first serve;**

Guidelines and Rules for Participation in the MST Farmers Market:

1. All vendors must supply their own equipment, tent, booth, tables, chairs, etc.
2. Vendor must occupy their own space and be ready to sell by 4:00 p.m. Vendors must participate in all scheduled events.
3. All products sold or handed out at the Farmers Market must be family appropriate and made in the U.S.A.
4. A limited amount of electrical power is available on a first come **for food vendors**, first served basis. Stipulate the maximum wattage needed on your application form. Electrical needs may limit the available vendor spaces and you must use the outlet assigned by the coordinator. Quiet generators are allowed with prior MST approval.
5. Sandbags or alternative weights must be used to hold down canopies or racks at all times;
6. The event ends at 7:30 p.m. and no vendor is to begin closing up before that time.
7. Each vendor is responsible for their own set up, break down and clean-up with all trash removed after the event no later than 8:30p.m.
8. **NO VEHICLES WILL BE PERMITTED ON OR OFF THE MARKET LOCATION DURING MARKET HOURS.**

Anyone found violating these rules will be asked to leave the event immediately with no refund.

The event always draws a crowd to Historic Downtown Tehachapi. We are committed to providing a wide selection of agricultural and locally made crafts. Thank you for your time and participation!

Non-profit or Community Service information booth only: \$10 per 10'x10' space.
