



Welcome Agricultural Vendors to the 2017 Tehachapi Farmers Market

The Farmers Market will be on Thursdays, from May 4 through August 17, between 4:00 to 8:00 p.m., on Green Street in downtown Tehachapi. There will be sixteen events with produce as the star attraction.

There is no commission to be paid on your sales. Your agricultural vendor application fee to Main Street Tehachapi includes the California Department of Food and Agriculture (CDFA) fee and a fee to the City of Tehachapi. There is a \$5.00 fee for a City of Tehachapi business license if you do not already have one. Your application fee also helps cover the costs of advertising and live entertainment.

Producers are responsible for their own signage at their stall in compliance with new state law: farm's name, county of production, Certified Producer certificate number, and state "we only sell what we grow". Producers are also responsible for any Kern County permits as required by that agency. No stakes may be driven into the ground. Please use sandbags or alternate means to anchor your canopies or free-standing signs.

The event always draws a crowd to Historic Downtown Tehachapi. We are committed to providing a wide selection of agricultural products to those citizens and an additional sales venue for our local growers. As always, you may park your produce truck near your space.

The attached application shows the fee structure based upon space size. Please take a moment to review and complete the enclosed application, then return it with your fee by mail. To pay by credit card, please contact the Main Street office at (661) 822-6519.
